**More Protests. More Often!** According to the *Minneapolis Star-Tribune*, community leaders from across Minnesota protested yesterday outside **Citadel** rocker KQRS/Minneapolis, more than a month after the station apologized for making insensitive comments about Indians on the **Tom Barnard** morning show. A large contingency from the **Communities of Color Council of Many Nations** demanded that KQRS fire host Barnard and co-host **Terri Traen**. They also demanded that Citadel stop programming it feels is "rooted in prejudice, bias and discriminatory stereotypes." The group gave a list of demands – new and apparently different than those presented to the station LAST month - to KQ attorney **David Valentini** urging the station to once again apologize in print and electronic media outlets and on its website. As a new demand, the group also wants to host a weekly half-hour program on the station. "We're not going to stand for it," said council member and prominent Indian activist **Clyde Bellecourt**. "We are going to teach Minnesota the truth about who we are as a people." Valentini said Thursday that the station had met its earlier commitments, including issuing on-air apologies, running public service announcements on KQ and two sister stations and hiring two Indian interns. "We came to an agreement, and we lived up to it," Valentini said. "As for the station firing Tom and Terri, it's the No. 1-rated morning show in the U.S. It's not happening." The controversy began in September when Barnard and Traen discussed the high suicide rate in a northern Minnesota county, which includes a large Indian Reservation. Traen mentioned genetics and incest "up there," and Barnard took a shot at the **Shakopee Mdewakanton** tribe for failing to help its own reservation with proceeds from its casino.

The **FCC** last week granted the sale of **Tribune Co.** to **Sam Zell**, the Tribune Employee Stock Ownership Plan, and EGI-TRB, LLC. There is still time-limited waivers of two years (or six months after litigation, whichever comes later) for the company's crossownership of newspapers and TV stations in New York, Los Angeles, Miami and Hartford and a permanent waiver in Chicago, where the company owns the *Chicago Tribune*, the *Red Eye* daily tabloid, **CW** affiliate WGN-TV and its only radio property, Talk WGN-AM. Calling the grant "a brazen reversal of 30 years of settled precedent," Commissioner **Michael**

**Copps** dissented, saying, "If this Order were a newspaper, the banner headline would read 'FCC Majority Uses Legal Subterfuge to Push for Total Elimination of Cross-Ownership Ban.'" Tribune gets at least a two-year waiver plus the ability to go to court immediately and see if they can get the entire rule thrown out. Most important, Tribune is not required to seek a hearing before the very court that expressly retained jurisdiction when it remanded the general newspaper-broadcast cross-ownership ban. Instead, Tribune can end-run the Third Circuit and petition for review before what it may hope is a more sympathetic court. "The more I think about this approach, however, the more troubled I become. Publicly, the Chairman claims to want only a 'modest' relaxation of the cross-ownership ban. Privately, he enlists Tribune as an accomplice to try and get the ban overturned in court. If the Chairman wants to eliminate the ban, he should stand up and say so. It's time to end the charade." Commissioner **Jonathan Adelstein** also dissented from the 3-2 party-line vote, saying, "While I disagree with the final decision in this case, I am more disappointed with the majority's disregard for Commission precedent and legacy. A simple two-year waiver would have accomplished the goals of the majority and the applicants. But instead, the Order employs certain novel, ill-advised and back-breaking legal gymnastics that will surely leave observers with their heads spinning."


**Clear Channel/Chicago** trimmed at least four staffers from its programming payroll Monday to shift its resources to Internet and sales ventures. Those let go include: **Armando Rivera**, whose APD/MD position was dropped at Urban AC WVAZ (V103). **Victor "The Diz" Blackful**, a veteran of Urban WGCI, was laid off as evening personality. Replacing him alongside **Frankie Robinson** will be **Leon Rogers**, who had been morning traffic reporter. At Top 40 WKSC (KISS 103.5), **Alexx Dupri** is out as overnight personality. To cover some of Dupri's former hours, **Billy Hammond's** late-night show will be extended. Also at KISS, **Pete Gallindo** is out as producer of **Kevin "Drex" Buchar's** morning show. An additional position of event manager in Clear Channel's promotion department also was eliminated. Explaining the layoffs, Pres./Market Mgr. **Earl Jones** said in a statement: "We are re-expressing our assets to achieve greater results. We will have more employees in 2008 than in 2007 as a result of an increased sales force and the establishment of a local Internet sales and programming division. We are not only a radio company — we are a platform for content." *Comment- Let's see if we get this straight. The removal of a programmer, two air talents and a producer...while promising to increase a sales force...is being done because "We are not only a radio company — we are a platform for content." Programming personnel: buh-bye. Lotsa sales people: come on down! Now we get it: "Content" has just become a new radio management buzzword for "commercials"! How brilliant! How original! The public is just gonna eat that up, won't they? Now, where did I put that iPod? - TK*

**Mike Kronforst**, longtime **Brown College** instructor and former **Conclave** Board member, has been selected to be recognized at the *2008 Student Success Celebration*. In receiving the honor, the **Career Education Corporation** (who sponsors the Celebration), says of Mike, "Throughout the past year, you have consistently demonstrated a dynamic attitude that has contributed to the success of our students and to your team. The services and education we provide each day are dependent upon exceptional people like you and we wish to take this opportunity to come together, to celebrate and to share best practices." He'll receive his award in February during *Student Success 2008* in Miami. CEC has about 90,000 students in 80 schools.

The **National Association Of Black Owned Broadcasters (NABOB)** Executive Dir./General Counsel **Jim Winston** testified before Congress and unveiled that **Arbitron** has applied for "re-accreditation" for the PPM methodology in Houston.

If so, that would be less than one year removed from **Media Rating Council (MRC)** accreditation of the market. Winston said, "additional factors have been uncovered," by The MRC that would jeopardize the Houston accreditation. In testimony, Winston asked the House subcommittee to force Arbitron and The MRC to make public the status of their review, as well as documents, meeting minutes and communications between the MRC and Arbitron. Asked Winston, "Please investigate Arbitron's new Portable People Meter Audience Measurement system, because it appears that within its design is a critical flaw in the gathering and processing of the audience data which has resulted in a clear bias against the reporting of minority audiences. That bias is compounded by Arbitron's failure to implement the PPM service in the manner in which Arbitron committed that it would. Initial results from the PPM measurements have shown such huge rating declines for stations serving Black and Hispanic audiences that the financial survival of these stations would be at stake if Arbitron were to implement PPM across the nation in the form it has been initially introduced. As it stands today, PPM is a greater threat to the survival of minority owned media than even the FCC's threatened ownership rule changes."

The **Arbitron Radio Advisory Council** announced that **NRG Media** COO **Chuck DuCoty** had been elected Chairman and **CBS/Seattle** Market Mgr. **Lisa Decker** was elected Vice Chairman. After the appointments, the Council weighed in on the current difficulties encountered by Arbitron, re: PPM: "We have just concluded three days of intense and productive meetings with Arbitron representatives. Over the past few weeks the industry has expressed firm support for electronic measurement and PPM for radio. The industry has made it clear that Arbitron needs to make significant improvements in the PPM sampling process and continue to improve diary measurement to ensure buyer and seller confidence in audience estimates for all stations and all audience targets in all markets."

An investigation has been launched by two powerful members of the House Energy and Commerce Commission of the **FCC** and Chairman **Kevin Martin**, charging "possible abuse of power" by not conducting business fairly and in the open. Rep. **John Dingell** (D-MI) and **Bart Stupak** (D-MI) have notified the commissioner and are looking into examples where Martin proposed rule changes and didn't provide enough time for other commissioners to review the proposal's before a vote was taken. The commissioners are scheduled to appear before the committee in an oversight hearing Wednesday, with a Senate committee also scheduled to hear testimony from the commissioners next week.

New ownership rules passed unanimously in a vote Tuesday in front of the Senate Commerce Committee. The rule will delay the FCC ability to approve new ownership rules for six months. The Commission was headed for a December 18<sup>th</sup> vote on rule changes but if approved by the Senate, House and signed by the President that will no longer be possible. Sen. **Byron Dorgan** (D-ND) said in sponsoring the bill. "Media ownership rules are important in a democracy. We won't allow the FCC to rush to judgment, and we won't allow the public to be shut out of the process."



"I am deeply honored that the President has announced his intention to nominate me to serve another term as Commissioner of the Federal Communications Commission," said Adelstein. "I would also like to express my deep appreciation to Majority Leader **Harry Reid** for his support and faith in me. If confirmed by the Senate, it would be a privilege to continue working to ensure that the American public has access to the best possible communications opportunities in the world."

Former **Conclave** keynoter, **Bob Pittman** will deliver the keynote speech during the NAB Show Radio Luncheon on April 15th in Las Vegas. Pittman programmed WDGY-AM/Minneapolis, WMAQ-AM/Chicago and WNBC-AM/New York before becoming CEO of **MTV Networks**, COO of **America Online** and, later, founder of investment group **Pilot Group LLC**, which, among other investments, has backed **Double O Radio**.

**Roadrunner Records** has named veteran promotion executive **Mike Easterlin** SVP/Promotion and will expand its promotion staff by combining with **Lava Records'** promotion team under the Roadrunner banner. Easterlin, who currently sits at the helm of Lava's promo department is set to join the Roadrunner staff on January 2nd. He replaces current SVP/Promotion **Dave Loncao**, who will leave Roadrunner at the end of the year.




